SECTION 33, TWP. 28 N., R. 4 E., W.M.

SNOHOMISH COUNTY, WASHINGTON

DESCRIPTION

This plat of Wingate Division 2 embraces that portion of the NW 1/4 of Section 33, Township 28 North, Range 4 East, W.M. Snohomish County, Washington, described as follows:

Beginning at the Northeast corner of Lot 5 in the plat of Wingate Division No. 1 as recorded in Volume 33 of plates, pages 50 and 51 records of said county; thence along the northerly boundary of said plat the following courses and distances: N 77°00'00" W 368.34 feet; N 55°00'00" W 270.00 feet; N 66°00'00" W 220.00 feet; N 6°00'00" E 280.00 feet, and N 84°00'00" W 490.00 feet to the Northwest corner of said plat; thence leaving said plat boundary N 4°00'00" E 232.00 feet; thence N 50°00'00" E 287.00 feet; thence N 20°00'00" E 227.00 feet; thence N 61°00'00" E 182.00 feet; thence N 81°30'00" E 272.00 feet; thence N 45°00'00" E 66.00 feet; thence S 36°34'44" E 267.90 feet; thence S 53°27'59" E 390.42 feet; thence S 1°07'48" W 1010.00 feet to the Point of Beginning abstracting an area of 25.9544 acres.

DEDICATION

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, owners in fee simple of the land hereby platted, hereby declare this plat and dedicate to the public forever, all roads, easements and ways shown hereon with the right to make all necessary slopes for cuts and fills, and the right to continue to drain said roads and ways over and across any lot or lots, where water might take a natural course, in the original reasonable grading of the roads and ways shown hereon.

Following the original reasonable grading of the roads and ways shown hereon, no drainage waters on any lot or lots shall be diverted or blocked from their natural course so as to discharge upon any public rights of way or to hamper proper drainage. Any enclosing of drainage waters in culverts or drains or re-routing thereof across any lot, as may be undertaken by or for the owner of any lot, shall be done by and at the expense of such owner.

EASEMENT PROVISIONS

An easement is hereby reserved for and granted to PUBLIC UTILITY DISTRICT NO. 1 OF SNOHOMISH COUNTY, GENERAL TELEPHONE COMPANY OF THE NORTHWEST, INC., and ALDERWOOD WATER DISTRICT, their respective successors and assigns under and upon the exterior 7 feet, parallel with and adjoining the street frontage of all lots in which to install, lay, construct, renew, operate and maintain underground conduits, cables, wires, water and sewer services, with necessary facilities and other equipment for the purpose of serving this subdivision and other property with electric, telephone, sewer and water service, together with the right to enter upon the lots at all times for the purposes herein stated. Also, each lot or tract is subject to an easement 2.5 feet in width parallel with and adjoining all interior lot lines for purposes of drainage and utilities.

No lines or wires for the transmission of electric current or for telephone use, CATV, fire or police signals or for other purposes, shall be placed or permitted to be placed upon any lot outside the buildings thereon unless the same shall be underground or in conduit attached to the building.

RESTRICTIONS

No lot shall be further sub-divided than shown on the face of this plat.

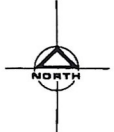
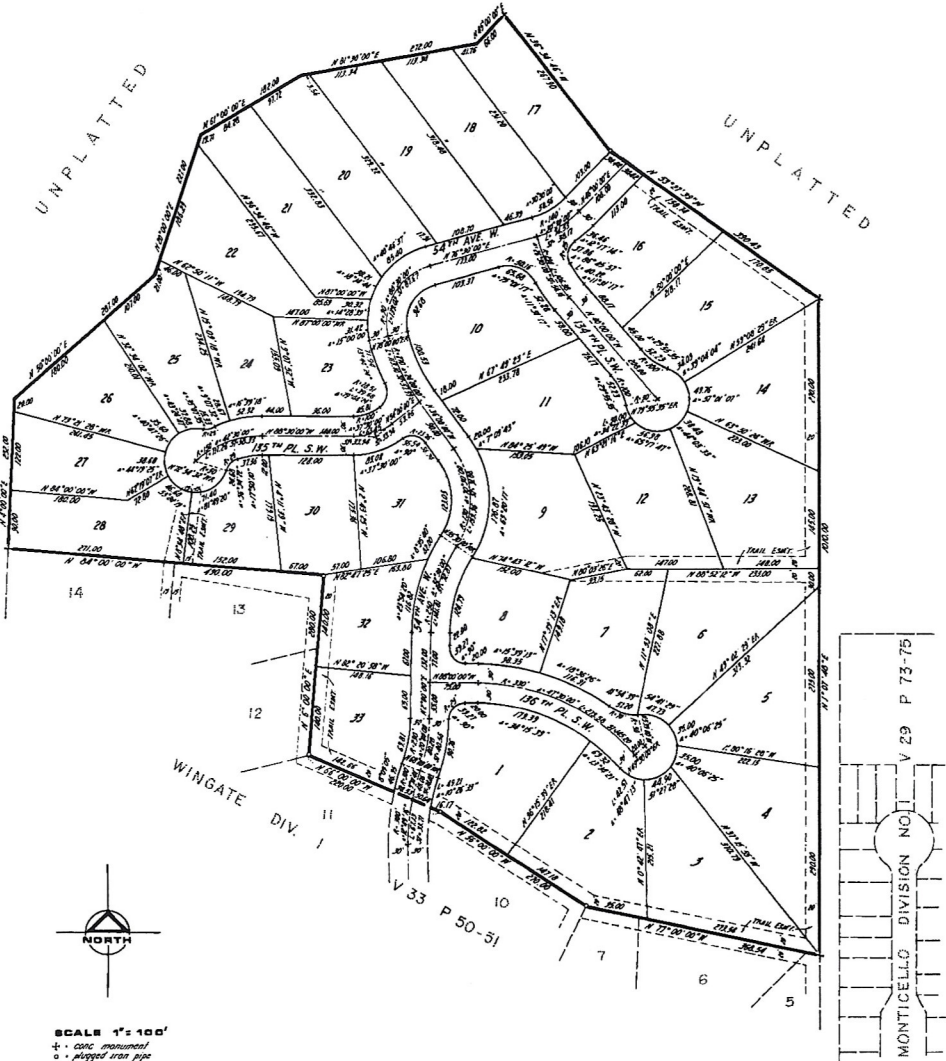

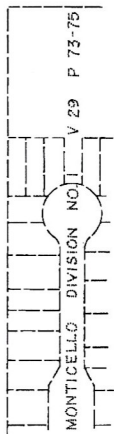
